** Failure to enroll within 30 days and accept the statement “Consent and Authorization” will result in a monthly Paper Statement Charge of \$1.00 and a statement will be mailed to you.

1. Start by opening Farmers State Bank homepage at <http://www.farmersstateonline.org>
2. Click on **Enrollment** (as seen highlighted above), you will be redirected to another page. Fill out all the information on the Confirm Your Identity page.

**Note- Date of Birth must be entered as -mm/dd/yyyy.

**Note- Social Security Number does not require dashes.

**Business account numbers = leave off preceding “0’s” of account number
Example: 0056789 needs to be keyed in as 56789

**Business accounts- please enter the EIN and business name (first name/last name)

3. Once identity is verified you will create a user name and password.

**Note password must contain at least 8 characters, 1 special character (!@#%&* ,.<>), 1 number and 2 alpha characters (upper and lower case letters).

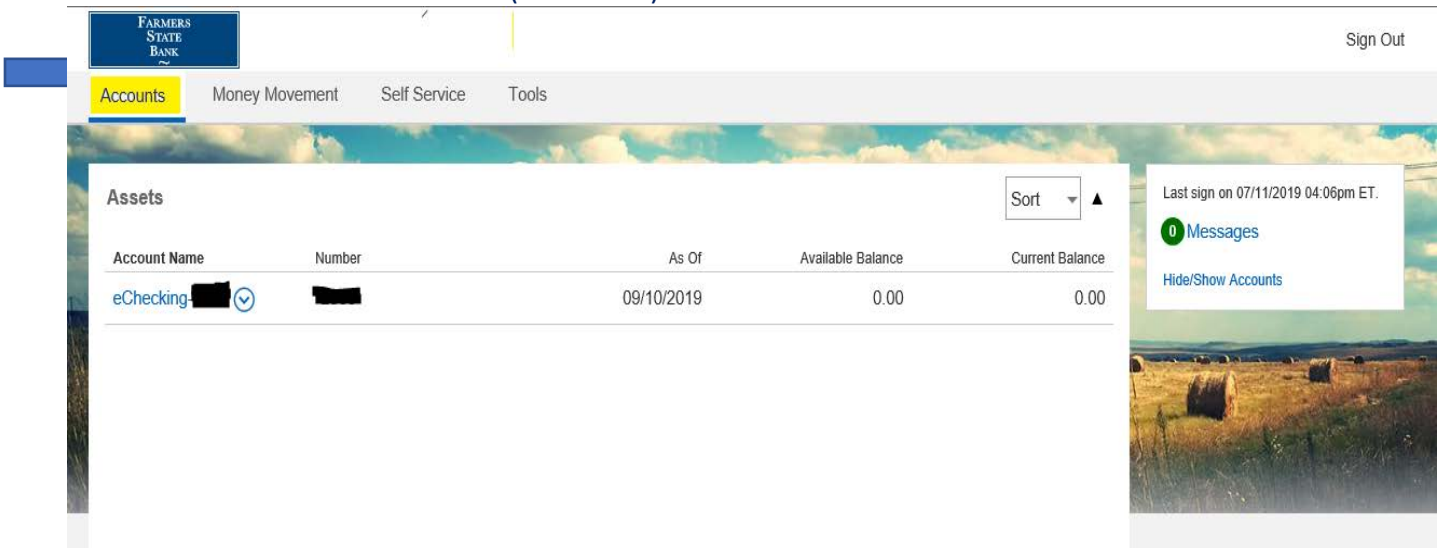

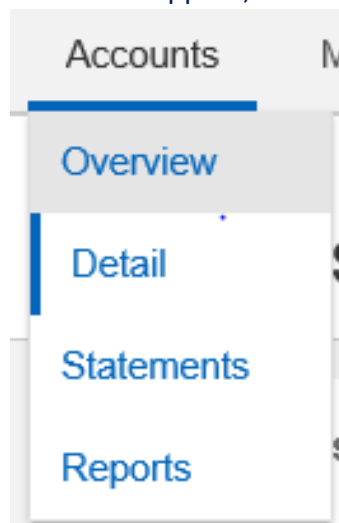

Once logged in, the screen will default to a list of your accounts as shown below.

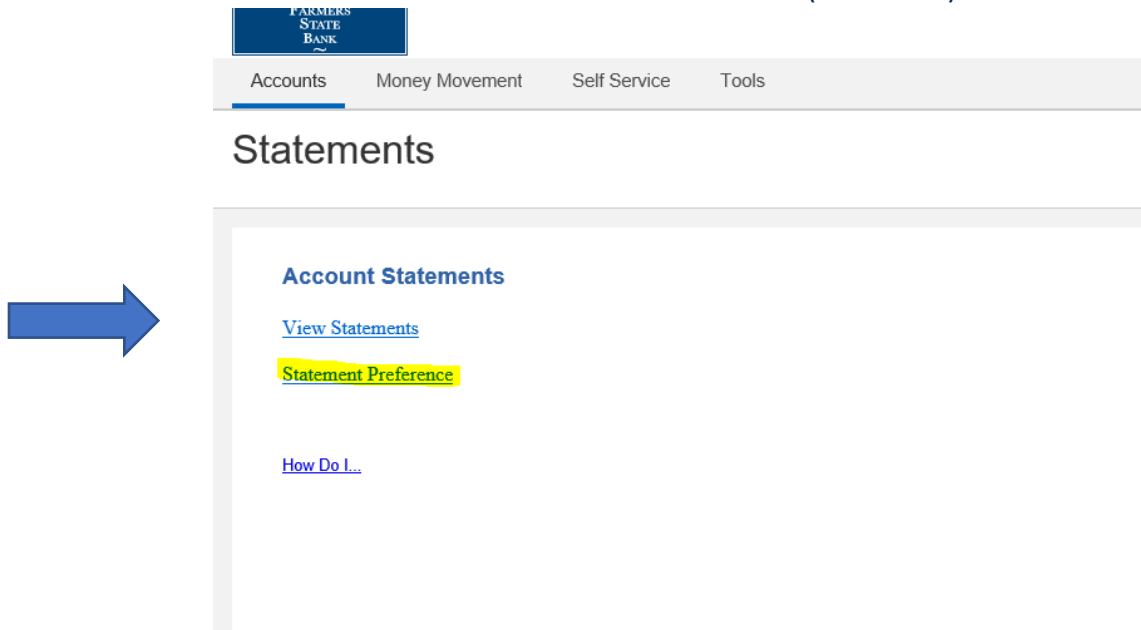
1. Click on the **Accounts tab** (see below)



2. A drop-down box will appear, select statements

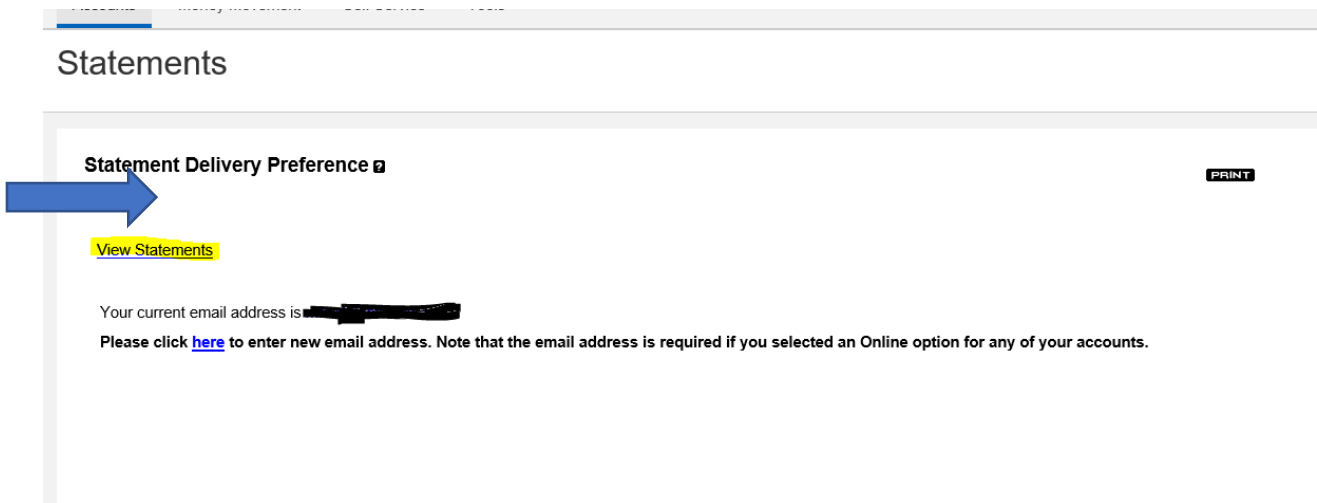


Click on Statement Preference (see below)

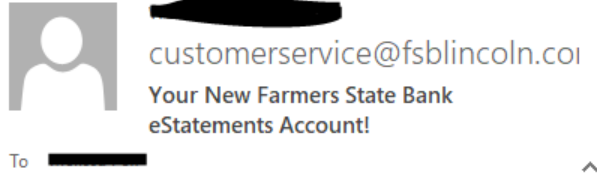
